DEED OF GUARANTEE AND INDEMNITY

In consideration of you granting credit terms to:

_____ (the "Applicant")

I/We _____ (the "Guarantor")

do jointly and severally agree with CSD as follows:)

1. The Guarantor guarantees to CSD the due and punctual:
 - (a) payment of all monies ("Monies") which may now or at any time in the future be owed by the Applicant to CSD for the supply of goods and/or services together with any interest or other costs or charges incurred in connection with attempting to obtain payment of Monies owed by the Applicant to CSD; and
 - (b) Observance and performance by the Applicant of the Applicant's obligations ("Obligations") under the Trade Credit Application Form for supply of the goods and/or services by CSD to the Applicant on credit.
 2. The Guarantor, as a separate and additional primary liability, indemnifies CSD against all loss (including unpaid Monies) and damage suffered or incurred by CSD by reason of the failure by the Applicant to pay the Monies or to observe the Obligations and as principal Applicants agree with CSD to pay to CSD when demanded in writing a sum equal to the amount otherwise recoverable by CSD against the Applicant. As the obligations of the Guarantor under this deed are principal obligations, CSD is not required to take any action first against the Applicant or make a demand first against the Applicant. I/We acknowledge that this obligation on my/our behalf shall extend also to any legal and other costs or charges incurred by CSD in seeking payment from the Applicant or in enforcing this Guarantee and Indemnity.
 3. This Guarantee is a continuing guarantee which will operate at all times the Applicant owes money to CSD and will not cease to operate by virtue only of:
 - (a) any indulgence given to the Applicant from time to time;
 - (b) any increase in the credit limit granted by CSD in the future;
 - (c) payment of any sum of money owed by the Applicant to CSD;
 - (d) any revocation made by the Guarantor;
 - (e) any amendment or alteration to the terms of credit or terms and Conditions of Sale of CSD at any time; or
 - (f) the Applicant appointing an administrator, a receiver, receiver and manager or in the event of the liquidation of the Applicant.
 4. It is acknowledged that the Guarantor is not executing this instrument as a result of or by reason of any promise, representation, statement or information of any kind given or offered to the Guarantor by or on behalf of CSD.
 5. The Guarantor hereby charges as beneficial owner and as trustee of every trust all of the Guarantor's real and personal property (including real property acquired in the future) in favour of CSD to secure the payment of the Monies and the performance and observance of the Guarantor's covenants under this deed. In this clause, "trust" means each trust for which the Guarantor holds land as trustee. For the avoidance of doubt, CSD is entitled to lodge a caveat over our real property to protect its interests as set out in this Guarantee and Indemnity.
 6. It is acknowledged that CSD may from time to time seek and obtain additional guarantees from other guarantors to guarantee the obligations and debts of the Applicant and we hereby consent to such further guarantees and acknowledge that such further guarantees do not diminish CSD's rights under this document.
 7. I / We acknowledge that this document constitutes a security agreement for the purposes of the Personal Properties Securities Act 2009 (Cth).
 8. If there is more than one guarantor, "Guarantor" means all of them collectively and each of them individually and the Guarantor's covenants are joint and several. "Co-surety" includes any other person named as Guarantor or who otherwise guarantees payment of the Monies.
 9. This deed binds the Guarantor's successors, executors, administrators and assigns and is a continuing and irrevocable Guarantee and Indemnity until the Guarantor is expressly released by CSD.
 10. The Guarantor's obligations under this deed are unconditional and not affected by anything which might otherwise affect them under the law relating to sureties.
- The Guarantor fully understands the risks associated with this deed and freely elects to execute this deed. Each Guarantor hereby acknowledges that it had read the terms of this Guarantee and Indemnity and has been:
- (a) advised to; and
 - (b) given the opportunity to, seek independent legal advice prior to execution.
12. The Guarantor consents to CSD collecting the Guarantor's personal information for the purposes as stated below.
 13. The Guarantor confirms that CSD may collect reasonably necessary personal information of the Guarantor for the purpose of processing the Applicant's credit account application, providing goods and/or services to the Applicant, preventing criminal activity and pursuing Applicants. If the requested personal information is not provided to CSD, CSD may not be able to provide the Applicant with a credit account, effectively provide the goods and/or services needed by the Applicant or otherwise achieve the said purposes.
 14. The Guarantor confirms that CSD may disclose personal information of the Guarantors that has been provided to it to third parties, such as debt collection agencies or credit reporting bodies for the said purposes.
